ORDER:-

The erstwhile Tamil Nadu Electricity Board, has been trifurcated into three Public Sector Undertakings viz., Tamil Nadu Electricity Board Limited, Tamil Nadu Generation and Distribution Corporation Limited and Tamil Nadu Transmission Corporation Limited with effect from 01.11.2010. Consequent on the above, the newly formed Corporations are governed by the Companies Act, 1956 (Central Act 1 of 1956). The Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited has stated that in the changed scenario, it becomes necessary to conduct the Departmental tests for the employees in a more specialized manner. The syllabi and the scheme of examinations which are followed by the erstwhile Tamil Nadu Electricity Board, are not relevant to the present conditions, particularly after the coming into force of the Electricity Act, 2003 (Central Act 36 of 2003) and in view of the incorporation of the said three entities under the Companies Act, 1956 (Central act 1 of 1956). Moreover, the accounting system has also been changed on various aspects, particularly Tamil Nadu Generation and Distribution Corporation Limited and other Corporations are following Commercial Accounting principles suggested by the Ministry of Power/Government of India. Hence, it has

been decided to conduct the departmental tests for the employees of the said Corporations (formerly Tamil Nadu Electricity Board) internally from November, 2013 onwards. The Board of Directors of Tamil Nadu Generation and Distribution Corporation Limited has also approved the proposal for conducting the departmental tests internally in Tamil Nadu Generation and Distribution Corporation Limited. The above fact has also been intimated to the Chairman, Tamil Nadu Public Service Commission.

3. The Principal Secretary/Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited has also stated that the Chairman, Tamil Nadu Public Service Commission has reported that the Departmental tests for all the Departments including Tamil Nadu Electricity Board are conducted by the Tamil Nadu Public Service Commission as per the orders issued in G.O.(Ms.) No.21, Personnel and Administrative Reforms Department, dated 10.01.2013 tests for its officials.

4. The Controller of Examination, Tamil Nadu Public Service Commission has stated that the proposal of Electricity Board has been placed before the Tamil Nadu Public Service Commission. The Tamil Nadu Public Service Commission has decided not to accept the proposal of the Electricity Board without any Government Order. The Commission's decision has also been informed to the Electricity Board. The Controller of Examination has also stated that the proposal of the Electricity Board may kindly be decided by the Government and necessary orders may be issued in this regard.

5. The Government have examined the recommendation of the Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited and the decision taken by the Tamil Nadu Public Service Commission and have decided to accept it. Accordingly, the Government direct that following Departmental Tests in the list of examination, which are conducted exclusively for the employees of Tamil Nadu Generation and Distribution Corporation Limited:-

105-Electricity Department Account Test – Paper-I and Paper –II
005-TNEB Test for Accounts Officers in the TNEB Part-I & Part –II.

172-TNEB –Test for App. as Int.Audit Officers – Audit Br.-Paper –I & Paper –II and included in the schedule of Departmental Examinations ordered in the G.O first read above be deleted and to keep the newly formed Tamil Nadu Generation and Distribution Corporation Limited, TNEB Limited and TANTRANSKO Limited from outside the purview of Tamil Nadu Public Service Commission for conduct of departmental exams. The Government also direct that the newly formed Corporations will determine its own internal arrangements for conducting examinations to its employees.
